The Company is also pleased to announce the declaration of distributions on shares of the Company’s 7.75% Series B Term Preferred Stock due 2026 (the “Series B Term Preferred Stock”). The Company has declared a distribution of \$0.161459 per share on its Series B Term Preferred Stock payable on each of January 31, 2022, February 28, 2022 and March 31, 2022. The following schedule applies to the distributions:

The Company has declared a distribution of \$0.135417 per share on its Series C Term Preferred Stock payable on each of

The Company's primary investment objective is to generate high current income, with a secondary objective to generate capital appreciation, primarily by investing in equity and junior debt tranches of collateralized loan obligations.
